2026 Neuromuscular Fellowship – United States

argenx supports the global healthcare community's independent initiatives (e.g., research, quality improvement, clinical advancement and education) to improve patient outcomes in areas of unmet medical need that are aligned with argenx medical and scientific focus areas.



Area of Interest

- The purpose of this RFP is to provide support for neuromuscular fellowship programs. Grants will be awarded at the institutional level, based on the organization's demonstrated ability to deliver expert mentorship, comprehensive training and guidance to the fellow. Preference will be given to programs with training and research in generalized myasthenia gravis (gMG) or chronic inflammatory demyelinating polyneuropathy (CIDP).

Timeline

- RFP Open: January 14th 2025
- Application deadline: March 30th 2025 (24:00 EST)
- Grant award notification: May 15th 2025
- Fellowship Start Date: July 2026 or later

Funding

- Grant funding is available to support one-year fellowships with an award of up to \$80,000 USD.

Applicant Eligibility Criteria

- Grants will be awarded to institutions, not individual physicians.
 - Accordingly, application materials must not include the names of prospective fellows or otherwise identify specific individuals who may participate in the fellowship program.
- Eligible institutions must maintain established neuromuscular fellowship

About argenx grants:

Decisions for grants are made through a formal, grant review and decision-making process. The Grant Review Committee assesses and approves applications based upon need, design, scientific rigor, independence and compliance. Approvals depend on available funding, the volume of requests, and alignment with argenx medical and scientific focus areas.

programs that incorporate independent research, structured clinical training and formal mentorship within the institution.

- Fellowship programs supported under this RFP must operate independently of argenx commercial business and assets.
- Independent research supported by the fellowship may include observational studies, outcomes research and other projects focused on advancing scientific understanding of neuromuscular disease, including evaluation of diagnostic or screening tools and their impact on patient health. Clinical training may include educational sessions with interdisciplinary teams, structured review of clinical case examples and relevant didactic training and use of tools aimed at improving patient health in specific therapeutic areas.
- Any clinical time funded by the grant must not be billed as patient care by the fellow.

Requirements for Fellowship

- The institution is responsible for ensuring that the fellowship program complies with all employment laws and citizenship requirements.
- The institution must ensure that its fellowship program supports fellows that possess an M.D. or equivalent degree and must be recent graduates of an accredited neurology or physical medicine and rehabilitation residency program.
- Any applicable payments will be reported in compliance with the U.S. Physician Payments Sunshine Act and other transparency regulations as required.

Fellowship Review and Approval Process

- Grant decisions for this RFP will be made by an **External Review Panel (ERP)**.
- The ERP consists of medical professionals with advanced degrees and expertise in neuromuscular medicine, U.S. based healthcare needs, learner groups, research, continuing professional development, or quality improvement programs.
- Proposals will be assessed based on key criteria, including:
 - Alignment with fellowship goals and objectives
 - Program structure and criteria
